Within the 2023 budget, the Board approved a 4.5% salary raise for all staff and raised the monthly health reimbursement stipend to \$347.38. At 5:08 PM Christina Burri made a motion to close the hearing. It was seconded by Karen Berry and the motion passed unanimously.

Bill Von Vihl made a motion to adopt Resolution 2022-60 which is to adopt the 2023 budget; to adopt Resolution 2022-61 to approve the appropriation of sums of money for the budget at \$1,645,283; and Resolution 2022-62 to set the mil levi at \$0.00.
