A new funding pool called Conservation Incentive Contracts will replace some of the EQIP and CSP contracts. NRCS is finalizing EQIP project approvals for this year.

Action Items

A motion was made by Christina Burri to approve Resolution 2021-05 to enter into a contract with Randy Jump for a forestry project and to approve Resolution 2021-06 to delegate specific

contract authority to Don Moore JCD Treasurer. The motion was seconded by Bill Von Vihl and the motion passed unanimously.

New Business/Old Business/Updates

Garrett Stephens provided the director's report. The new forester, Tatum VanDam, will start April 26. The NACD Urban Ag Grant that is in cooperation with the City of Wheat Ridge was funded.

Cathy Begej noted that wood strand mulch for erosion projects is very scarce. The Board discussed if it was possible for wood from JCD projects to be converted into this type of mulch.

Lorrie Ray made a motion to adjourn the meeting, it was seconded by Gayle Gordon and passed unanimously. The meeting was adjourned at 5:31 pm.
